SUMMARY ANNUAL REPORT

This is a summary of the annual report for New York State Teamsters Council – United Parcel Service ("UPS") Retiree Health Fund (the "Plan"), EIN 46-4111565 Plan No. 501, for the initial Plan year ended December 31, 2014. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees has committed itself to pay certain hospital, surgical, medical, dental, vision, prescription drug, and other health related claims incurred under the terms of the Plan.

Insurance Information

The Plan has contracts with Excellus Health Plan, Inc. (d/b/a Excellus BlueCross BlueShield Central New York Region), EBS-RMSCO, Davis Vision, Inc., and Medco-Express Scripts to pay health, dental, vision and prescription drug claims incurred under the terms of the plan. The total premiums paid for the plan year ended December 31, 2014, were \$1,614.

Basic Financial Statement

The value of Plan assets, after subtracting liabilities of the Plan, was \$34,516,315 as of December 31, 2014. During the year, the Plan experienced an increase in its net assets of \$34,516,315. This increase includes unrealized appreciation of \$626,381 in the value of the Plan's assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year.

During the Plan year, the Plan had a total income of \$34,917,712, including employer contributions of \$34,000,000, participant contributions of \$15,250, realized gains of \$244,842 from the sale of assets and earnings from investments of \$31,239. Plan expenses were \$401,397. These expenses included \$347,831 in administrative expenses, and \$53,566 in benefits paid to participants and beneficiaries.

- 5. Loans or other obligations in default or classified as uncollectible;
- 6. Leases in default or classified as uncollectible;
- 7. Transactions in excess of 5% of plan assets;
- 8. Insurance information including sales commissions paid by insurance carriers; and
- 9. Information regarding any common or collective trusts in which the plan participates.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
